ORDINANCE NO. 2010-01

**AN ORDINANCE AMENDING AND RESTATING THE FREEDOM OF
INFORMATION ACT POLICY FOR THE ST. CHARLES COUNTRYSIDE FIRE
PROTECTION DISTRICT**

WHEREAS, the St. Charles & Countryside Fire Protection District, Kane County, Illinois (the "District") is a fire protection district duly organized and existing under the laws of the State of Illinois; and

WHEREAS, the Illinois Freedom of Information Act, 5 ILCS 140, *et seq.* (the "Act") provides that every public body shall adopt and implement a written policy for the disclosure of public records subject to the Act; and

WHEREAS, the District is a "public body" subject to the Act; and

WHEREAS, the Board of Trustees of the District has heretofore adopted an amended and restated FOIA policy pursuant to Resolution No. 2008-06 and now desires to further amend and restate its said policy as hereinafter set forth;

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the St. Charles & Countryside Fire Protection District, Kane and DuPage Counties, Illinois as follows:

Section One: The Board finds and determines the above recitals to be true and correct, and by this reference incorporates them herein as if fully set forth.

Section Two: The Freedom of Information Act Policy attached hereto as Exhibit "A" and made a part hereof as if fully set forth is hereby adopted.

Section Three: The schedule of documents kept and maintained and available shall be amended and updated by District Staff from time to time as appropriate. The District's

webmaster is hereby authorized to update the District's website with new or revised information provided by staff as appropriate.

Section Four: Resolution 2008-06 and all other Resolutions or Ordinances in conflict with any of the provisions of this Ordinance are hereby repealed.

Section Five: The provisions of this Ordinance shall be in full force and effect upon its adoption.
